The Radar Unit was discussed for the Police Department. There was much discussion concerning this matter. Bill Ellison made the motion to purchase this unit. Fay McClenny second the motion under the stipulation that the police have the unit mounted in the car at all times unless okayed by the council or mayor. All approved. Doris Culver abstained.

At this time the extended warranty for the new police car was discussed. This warranty will be four year or 100,000 miles for \$490.00. Bill Ellison made the motion to by this warranty and Doris Culver second. All approved.

It was reported that the road at Coosada Street was in bad shape. The county could work this road and the Town would pay for it. Bill Ellison made the motion to contact Mr. Rooks on this matter and get it done. Doris second the motion, all approved.

It was stated that on Thursday, July 16, 1992 would be the final inspection for the new sewage plant.

The JDT Well pump was stated that we need a new pump. In looking at the reports that are made, the same amount of water is now

At this time it was stated that Marlin White requested that the Street sign on his street be changed to Palm Street. Catherline Slater made the motion to do so. Bill second the motion, Mayor Wingard voted yes with Doris Culver and Mariah abstaining.

## MINUTES

Rockford water lines are presently only one mile from the Elmore County water system. *Elmore* Rockford will need to build a treatment plant if a "yes" vote is obtained for the hook-up. Rockford Waterworks would pick up approximately 680 customers from this merger and no problem with water supply is anticipated.

Visitor, Willie Zeigler, asked if customers in the Ray Community district would be getting service from Rockford Waterworks. It was stated that the Ray Community is presently serviced by the Ray Waterworks and that Rockford could not put lines parallel with Ray to pick up their customers. Mr. Zeigler stated that some of the residents do not have any water service. Larry Carden is to check into this and see why they have no service. He was reminded by Patricia Wingard that Rockford and Ray had a dispute previously concerning this area in question.

The question of cost difference in water price was raised by Sheryl Goggans-Borden and Larry Carden assured her that the cost would remain at \$1.26 per 1000 gal. If Rockford hooked up with Alexander City water, all of the funds in the account would be depleted.

The question of the 40-year contract with Ray Water was raised by Bill Crew. Patricia Wingard said that was no problem, Ray had not honored the contract and it would be very easy to break. Larry Carden proposed that Rockford keep Ray as a back-up water system.

First order of business was the swearing in of new Mayor, Wayne Windsor and members of the Town Council, Bill Ellison, Doris Culver, Fay McClenny, Catherine Slater, Margie Lee, and Fred Sneed. Patricia Wingard then turned the meeting over to new Mayor, Wayne Windsor.

Mayor Windsor introduced the guests and invited their proposal to the community. Mr. Ronnie Windham presented their plan for water hook-up with Equality (Elmore County) water system at a cost of \$401,500. This will include an 8" water main connecting two 6" lines along highways 9 and 14. They wanted approval from the Gas, Water, and Sewer Board for them to apply for a \$200,000 grant to help with the cost. Rockford would be expected to match the grant amount. Their proposal would extend 3/4 mile into Elmore County. Larry Carden brought up the question of whether Elmore County would pay for that portion of the line.

Bill Ellison brought up the subject of areation to treat the radon. He was told that ADEM would not approve the cost for that type of solution because Rockford does not meet the 51% low to moderate income criteria.

Visitor, Bill Williams asked why we could not build a filtration plant on Hatchett Creek and use the water from there. Patricia Wingard stated that it had been checked on and the cost was too high at approximately \$3,000,000. Mr. Windham requested a resolution be adopted to apply for application for a grant. Larry Carden suggested we wait and have Elmore County Water Board at the next Gas, Water and Sewer Board meeting on November 10, at 7:00 p.m. It was decided to discuss further with them.

BE IT ORDAINED BY THE TOWN COUNCIL OF ROCKFORD, ALABAMA, that the order of procedure in all instances for meetings of the council shall be as follows:

- SECTION 1. That the rules or order of procedure herein contained shall govern deliberations and meetings of the Council of Rockford, Alabama.
- SECTION 2. Regular meetings of the Council shall be held on the following dates: THE SECOND TUESDAY OF EACH MONTH.
- SECTION 3. Special meetings may be held at the call of the Mayor by serving notice on each member of the Council not less than twenty-four hours before the time set for such special meeting; or special meetings may be held as provided by Section 11-43-50, of the Alabama Code, whenever two aldermen request in writing that the presiding officer call such meeting; upon the failure or refusal of the presiding officer to call such meeting when requested, the two aldermen making the request shall have the right to call such meeting.
- SECTION 4. A quorum shall be determined as provided by Section 11-43-48, Code of Alabama.
- SECTION 5. All regular meetings shall convene at 7:00 P.M at the Town Hall and all meetings, regular and special, shall be open to the public.
- SECTION 6. The order of business shall be as follows:
1. A call to order
  2. Roll call
  3. Reading of the minutes
  4. Reports of standing committees
  5. Reports of special committees
  6. Reports of officers
  7. Reading of petitions, applications, complaints, appeals, communications, etc.
  8. Auditing accounts
  9. Resolutions, ordinances, orders, and other business.
- SECTION 7. No member shall speak more than twice on the same subject with permission of the presiding officer.
- SECTION 8. No person, not a member of the council, shall be allowed to address the same while in session without permission of the presiding officer.
- SECTION 9. Every officer, whose duty it is to report at the regular meetings of the council, who shall be in default thereof, may be fined at the discretion of the council.
- SECTION 10. Motions shall be reduced to writing when required by the presiding officer of the council or any member of the Council. All resolutions and ordinances shall be in writing.
- SECTION 11. Motions to reconsider must be by a member who voted with a majority, and at the same or next succeeding meeting of the council.



- SECTION 14. The presiding officer of the council may, at his discretion, call any member to take the chair, to allow him to address the council, make a motion, or discuss any other matter at issue.
- SECTION 15. Motions to lay any matter on the table, shall be first in order; and on all questions, the last amendment, the most distant day, and the largest sum shall be first put.
- SECTION 16. All meetings of the council shall be public.
- SECTION 17. A motion for adjournment shall always be in order.
- SECTION 18. The rules of the council may be altered, amended or temporarily suspended by a vote of two-thirds of the members present.
- SECTION 19. The Chairman of each respective committee, or the Councilman acting for him in his place, shall submit or make all reports to the council when so requested by the presiding officer or any member of the council.
- SECTION 20. All ordinances, resolution or propositions submitted to the council which require the expenditure of money shall lie over until the next meeting; provided, that such ordinances, resolution, or propositions may be considered earlier by unanimous consent of the council; and provided further, that this rule shall not apply to the current expenses of, or contracts previously made with, or regular salaries of officers, or wages of employees of the Town.
- SECTION 21. The Clerk, Engineer, Attorney, and Chief of Police, and such other officers or employees of the Town of Rockford, shall, when requested, attend all meetings of the Council and shall remain in the council room for such length of time as the council may direct.
- SECTION 22. No ordinance or resolution of a permanent nature shall be adopted at the meeting at which it is introduced unless unanimous consent be obtained for the immediate consideration of such ordinance or resolution, such consent shall be by roll call and the vote thereon spread on the minutes.
- SECTION 23. This ordinance shall go into effect upon the passage and publication as required by law.

Joint Meeting Town Council and  
Gas, Water & Sewer Board

November 10, 1992

A joint meeting was held on November 10, 1992, at 7:00 p.m. at Town Hall by the Town Council and Gas, Water & Sewer Board. All members were present. Larry Carden and Bill Crew were late.

Meeting was called to order by Mayor Windsor. Visitors were recognized and asked to state their business. First was Mr. Young representing the Coosa County Board of Education. He was told he would have to wait to discuss his business since it concerned the Gas, Water and Sewer Board and both the Chairman and Vice-Chairman were not present yet.

Next, Jo Scarbrough was recognized and asked her purpose for being present. She stated she had three items for discussion. First, she wanted to be placed on a rotating basis for gas and oil purchases for the town. She stated she would be willing to pump the gas for the policemen if that was a problem for them. Mayor Windsor told her that Patricia's letter to the businesses concerning rotation of business included service on vehicles also. Mrs. Scarbrough stated Patricia told her she could have gas and oil purchases on a rotating basis and she was the only one who had responded to the letter. She requested the Council talk it over and get back with her on their decision.

Next, Mrs. Scarbrough said she would like to have police protection when she closes the Circle S at night. She said Mike comes when he is on duty, but Allen Rambo very seldom comes down. She was told there was no problem if she closes at the same time every night. She stated she closes at 8:00 p.m. Monday through Thursday and 9:00 p.m. Friday through Sunday. She said she understood if they had a call and could not come by. Mayor Windsor said he would bring this to Allen's attention that he make an effort to be down there when she closes if at all possible.

Her third item was that she said she was told last year that she turned in more business than any one else in town, therefore, that was the reason her business license was more than anyone elses. She wanted to have that checked out this year and does not want to pay more than other companies for her license. She was told by Mayor Windsor that business license is computed on a percentage of gross sales. She said she understood that, but people who worked at Discount Food Mart said they did more business from 3:00 to 11:00 than she does in two days, therefore, Discount Food must be doing more business than she does. Mrs. Scarbrough was told that if they were cheating on their sales tax forms, all we could do would be call Alabama Dept. of Revenue, that it was not the Town's policy to play favorites.

Financial statements were reviewed by Town Council members. Doris Culver asked about random drug testing and was told they were done in September and billed in October. No further questions on financial statements.

Motion to appoint Bill Williams to East Alabama Solid Waste Disposal Authority was made by Bill Ellison and seconded by Fay McClenny. All approved. Council agreed to pay gas mileage when he drives to meetings.

Mayor Windsor suggested Keith Lewis, John Harris and Bruce Poppell be named to the Parks and Recreation Board. Fay McClenny made motion to accept, Bill Ellison seconded. All in favor.

The Christmas parade will be held Friday, December 4, 1992 at 7:00 p.m. Motion was made by Bill Ellison to allot \$100 for prize money for the best three floats. Fay McClenny seconded; all approved. Contacts for the parade are Glenda Cardwell, Carl Jones and Shirley Ogle.

The police schedules were discussed. At present, the police make their own schedules. Mayor Windsor said he had a plan in mind of 12 hour days-- one week 48 hours, 36 the next. The other police will work opposite at 36 and 48 hours respectively. This would give each 8 hours overtime at time and a half every two weeks. It was felt that this would eliminate comp time. Fay McClenny made a motion for Wayne to draw up a schedule for the council to approve at the next meeting. Fred Sneed seconded; all agreed.

Larry Carden called the Gas, Water and Sewer Board to order and invited Mr. Young to address the Board. Mr. Young's questions was for approval to eliminate two meters charged to the school -- one at football field and one at the old Home Ec building. The water would go through the other meters at the school, since these two in question have very little usage. Larry Carden told him the policy was that no two buildings could be hooked to the same meter. Every sewage outlet has to have a meter and there are bathrooms at the ballfield. Mr. Young wanted to know if they could use the septic tank at the ballfield. He was told they had to tie onto the sewage system. Larry Carden told him they would have to leave the meters hooked up because of the sewage.

Catherline Slater asked if the Town had connected to sewage yet. Mayor Windsor explained that we had not because we are on the same septic tank as Demp Johnston and he is having to wait on Phillip Goolsby to do his lines. Randy and Carlton will do the Town's lines at the same time that Phillip does Mr. Johnston's because of the septic tank having to be destroyed.

Gas, Water and Sewer Board Financial Statements were discussed. No questions.

Motion to pay Kenny Cates for maintenance and lab work \$615 was made by Catherline Slater and seconded by Burch Mitchell. All in favor.

Motion was made by Catherline Slater to pay Coosada Trucking \$2574.47 for gravel hauled to the sewage plant and seconded by Perry Ellison. All in favor.

Motion was made by Catherline Slater to appoint Wayne Windsor as Superintendent of the Gas, Water and Sewer Board. Perry Ellison seconded. All approved.

Perry Ellison made a motion to waive a \$40 deposit for gas for the Volunteer Fire Department. Burch Mitchell seconded. All in favor.

Minutes from the last joint meeting held October 5, 1992, were read by Alice McGrady and were approved by both the Town Council and Gas, Water and Sewer Board as read.

Doris Culver wanted to know why the Elmore County representatives were not at this meeting. It was explained that this was their regular board meeting night also and that they had called to say they would try to make the December meeting.

Unaccounted water report was reviewed.

Delinquent accounts were discussed. Burch said he would pay I.W. Mitchell's bill the following day.

Discussion was held concerning tax on late fees for gas, water and sewer bills. It was decided that Alice or Glenda would check and see if our software is presently capable of adding this tax or if we needed an adjustment to our program.

Motion was made by Perry Ellison to accept insurance coverage from Coley Insurance Agency for windstorm, fire and lightning for \$900 per year. Motion was seconded by Burch Mitchell. All in favor.

It was agreed that Alice send letters to the jail and school about their grease disposal. There is still a lot of grease being put into the sewer system.

Raises for town employees were discussed. It was determined that they have not had a raise in pay for the past year and a half. Mayor Windsor suggested a 5% increase in salary. Doris Culver made a motion to raise Town employees' by 5%. Fay McClenny seconded. All in favor. After much discussion, Perry Ellison made motion for the Gas, Water and Sewer Board to approve the 5% increase. Catherline Slater seconded. All in favor.

Larry Carden brought the question before the Town Council in behalf of the Rockford Men's Club as to purchasing a dummy deer for fines for hunting in city limits. The cost would be \$200.00. They have been approached by Allen Rambo and Earl Brown asking that Rockford Men's Club purchase the deer and they would spend their off-time monitoring it at night. Visitor, Jo Scarbrough, suggested that the Town Council pass an ordinance of no discharging fire arms in city limits. Bill Ellison stated he would go along with that if it were night only. Mayor Windsor said the Town does not need to get involved in conservation officer jobs, namely night hunting cases; that the State has jurisdiction inside the city limits anyway and he could not see how any revenue would come to the Town.

Discussion was held on Jo Scarbrough's question as to rotation of gas and oil purchases. Motion was made by Bill Ellison and seconded by Fay McClenny for new letters to be sent to all businesses selling gas asking if they wanted part of the Town's business for gas and oil sales. If the Town needs complete service, no matter whose month it was for gas sales, Texaco would do the service. All in favor of new letters being sent.

Motion to adjourn by Bill Ellison for Town Council. Seconded by Fay McClenny, all in favor.

Motion to adjourn was made by Catherline Slater for the Gas, Water and Sewer Board; seconded by Perry Ellison. All in favor.

## M I N U T E S

The regular monthly meeting of the Rockford Town Council was held at Rockford Town Hall December 8, 1992, at 7:30 p.m. All members were present.

Meeting was called to order by Mayor Wayne Windsor.

Visitors were recognized. The Boy Scout troop was present to observe the proceedings. Ronnie Windham of Goodwin, Mills and Cawood and James Deedees of East Alabama Planning & Development were present to give a cost analysis of the Rockford - Elmore County water connection.

Mr. Windham gave out copies of the cost analysis to members of the Council and explained that this was an estimate that could be added to or deleted from. His total cost estimate was for \$445,000 for completion of the project.

Mr. Deedees stated Rockford would need to put up 50% of the project cost to write a grant application. This money could be in cash or in-kind labor. Town Council is to be aware that they must apply for the block grant during the dates of February through April. If they miss the application date, they must wait another year to be eligible to apply. Mr. Deedees will check into other means of getting money for the project.

Bill Crew was recognized and asked to state his purpose for visiting. He asked in behalf of the Gas, Water and Sewer Board about a loan that the board pays to General Fund in the amount of approximately \$500 per month. He was told that the loan was for 20 years and they had paid only five years on the loan.

Mr. Crew also wanted to make a formal complaint against Waste Away. He said they have not been picking up all of his garbage and he pays \$20 per month for this service, while residences pay only \$8 per month. He was told by Waste Away that he could put extra boxes in the trash if they were neat. The driver for Waste Away told him they were not supposed to pick up extra trash that was not in the can. He placed a call to the Waste Away dispatcher and was told they would pick up this time, but not any more. Visitor, Donna Goff, stated they still pick up her extra trash and Mayor Windsor said they still pick his up also. Bill Ellison

said his wife cleans the Medical Clinic and they always pick up the extra bags they have there. Mayor Windsor will check into the matter for Mr. Crew.

Minutes of the November 10 meeting were read by Alice McGrady and stood approved as read.

Discussion was held on hunting within the Town limits. Mayor Windsor said it would be pretty hard to tell a person he could not hunt on his own property. He will discuss the matter with the City attorney.

Financial statements were reviewed.

Motion to pay attorney fee in redistricting suit was made by Bill Ellison and seconded by Fay McClenny. All in favor.

Bill Ellison made a motion to adopt a resolution to accept Bill Williams as committee member to East Alabama Solid Waste Disposal Authority. Fay McClenny seconded. All in favor.

Auditor, Henry Dunlap, discovered a discrepancy in the final payment to John Davis on the purchase of property. The Town owes him \$322.91. Motion to pay was made by Fay McClenny and seconded by Doris Culver. All in favor.

Mayor Windsor told the Council that the old police car needs replacing. The motor needs rebuilding at an approximate cost of \$1500. The state is having a sale Friday with 8 to 10 supervisor cars from the State Troopers at a cost of \$1800 to \$2500. He stated the back-up police car we have is worn out and we have the money in savings to afford another one. Doris Culver said she could not see the need for another police car and asked where the new car was. She was told Mike drove it to school this week. When the old one broke down, it left the Town without a police car. Bill Ellison made a motion that a ceiling cost of no more than \$3,000 be put on the purchase of a back-up car and that Wayne, Mike and Allen should go to the sales on Friday. Fay McClenny seconded. Bill Ellison, Fay McClenny, Margie Lee and Fred Sneed approved. Doris Culver opposed.



Police schedules were again discussed. Mayor Windsor submitted his proposed schedule of 12-hr. shifts. He said they would be getting 8 hrs. per pay check overtime, but it should eliminate comp time. Fay McClenny made a motion to accept the new schedule beginning January 1. Doris Culver seconded. Margie Lee and Fred Sneed were in agreement. Bill Ellison declined to vote.

Wayne is to remind police of checking doors and keeping a log book.

Bill Ellison requested a letter be written to merchants concerning double parking by delivery trucks in front of their stores, which blocks one lane of traffic and makes it virtually impossible for anyone pulling onto 231 to see traffic.

Gas and oil purchases for the Town will be made on a rotating basis between Circle S Market and Rockford Texaco, beginning January, determined by letters returned to Town Hall.
